I am a senior research and teaching fellow based at the University of Oxford Department of Social Policy and Intervention. My research is focused the implementation, effectiveness, and scale-up of programmes that improve child and family wellbeing and mental health outcomes in low- and middle-income countries.

I am the lead principal investigator of the Global Parenting Initiative which is a 5-year \$22 million project aimed at expanding the evidence and impact of human-digital playful parenting interventions in the Global South. I am also a principal investigator on multiple research projects in Jamaica, Malaysia, Moldova, North Macedonia, Philippines, Romania, South Africa, Sri Lanka, Tanzania, Thailand, and Uganda.
